In recognition of valuable contributions of our teachers and to take New Education Policy (NEP) 2020 a step forward, like the previous year this year too, the Department of School Education & Literacy, Ministry of Education, Govt. of India, has decided to celebrate ShikshakParv-2021 commencing from 7th September, 2021 till 17th September 2021 through virtual mode. The theme for this year's ShikshakParv has been decided as '*Quality and Sustainable Schools: Learnings from the Schools.*

The inaugural conclave will be held on 7th September, 2021 at 11 AM wherein Hon'ble Prime Minister of India will address the stakeholders associated with education. It will be followed by webinars, discussions, presentations etc. up to 17th September, 2021 in which the educational practitioners from various schools of the country have been invited to share their experience, learnings and the road map ahead.
